For the health and safety of our LISG community, we ask that families remain vigilant in and out of LISG. If everyone is mindful of their behavior, our community will be safer.

While our Reopening Plan has been carefully designed to mitigate the risk of COVID-19, such a risk cannot be eliminated.

Therefore, please restrict your travel during the academic year. If you cannot, I ask that your child(ren) quarantine and use the online platform until it is safe to return.

Please know that the staff at LISG will follow the same guidelines as our families. Together, let us do our best to maintain a healthy community.

REQUIREMENTS IN SCHOOL

1. **Face Masks are a Must.**

Face masks help prevent the spread of COVID-19. It is possible to have coronavirus without showing symptoms, so every person in our community will wear a mask. There are no exceptions to this rule. Only approved face masks are permitted. Neck gaiters and open chin bandanas are prohibited.

2. **Physical Distance is a must.** All classrooms are designed for distancing. In addition to all classroom teachers, there will also be hallway monitors.

3. **In wayfaring** - directional signage allows for a unified flow. Floor decals and signage in the hallways and bathrooms gently remind everyone to follow the protocols.

4. **Practice good hygiene and self-care** – hand sanitizing stations have always been in classrooms and hallways. This year students/staff are required to sanitize before entering the classroom. Every LISG community member is expected to wash or sanitize their hands frequently and monitor their own health.

I ask that families shift to remote, if you cannot follow the spirit of this agreement.

REQUIREMENTS WHILE REMOTE

While students are remote learning, we kindly ask that families adhere to the following guidelines to create and support a positive learning environment. Please review the following with your child and members of your household.

For Students:

- You are to be school-ready and dress appropriately for Remote Learning:
 - No pajamas, please. Shirts and bottoms are expected.
- Be sure your computer is charged or plugged in, and that you are ready to join classes before they begin.
- Your camera must be on and your microphone muted.
- Please eat only during break times so that you can focus on your classes.
- Have all materials prepared:
 - Notebook, pen/pencil, text/workbooks or other items designated by the teacher.

For Parents and Others in the Home:

- Individual questions to the teacher should be asked at a later time.
- Ensure that pets are not a distraction to the learning of your child and others.
- Please be aware of the background of your child's screen:
 - Consider having the computer face a wall so that students are not distracted by other happenings in your home.
 - Be aware that family members also should be dressed appropriately in the background.
- Please be aware of conversations and noises in your home that may be heard by the students working remotely.
